

Mandatory standards and bans

A supplier's guide to current standards and bans under the national product safety system

About this guide

This guide outlines the current mandatory standards and bans under the national product safety system. Products include consumer goods, which are intended to be or are likely to be for personal, domestic or household use. Product-related services such as installation, maintenance, repair, cleaning, assembly or delivery of consumer goods are also included.

The guide provides information on the types of requirements under the mandatory standard and where you can access further information if you currently supply this product.

This guide is current as at 9 September 2014. Standards and bans are constantly being reviewed and updated.

Mandatory standards




Mandatory standards are introduced when considered reasonably necessary to prevent or reduce the risk of injury to a person. This means that certain consumer goods or product-related services must meet particular safety criteria before they can be supplied in Australia.

Bans






Bans can be placed on consumer goods or product-related services if there is evidence of a risk of serious injury, illness or death associated with the goods or services.





A ban can be interim (temporary) or permanent.

	<p>Gas masks containing asbestos</p> <p>There is a ban on gas masks with asbestos breathing devices. 	<p>Glucomannan in tablet form</p> <p>There is a ban on glucomannan in a tablet form. 	<p>Jelly cups (mini) containing konjac</p> <p>Mini jelly cups containing konjac are banned. These small confectionery products are mouth-sized jelly cups and are no more than 45mm in height and width. Konjac is a binding food additive that comes from the root of the konnyaku plant. 	<p>Magnets – small, high powered</p> <p>There is a ban on small, high powered magnets that are loose or separable. This ban applies to magnets that are small enough to fit into the small parts cylinder, have a magnetic flux of 50 or more and are marketed by the supplier as, or supplied for use as a toy, game or puzzle (including but not limited to an adult desk toy, an educational toy or game, a toy, game or puzzle for mental stimulation or stress relief); a construction or modelling kit; or jewellery to be worn in or around</p>

	<p>the mouth or nose.</p> <p>Ban: Consumer Protection Notice No. 5 of 2012</p> <p>Legislative instrument ID: F2012L02171</p>
	<p>Mini motorbikes with unsafe design features</p> <p>There is a ban on unsafe mini motorbikes that have unstable structures and mechanical flaws, lack an emergency stopping device, lack effective brakes and steering and/or lack adequate footholds.</p> <p>Ban: Consumer Protection Notice No. 14 of 2011</p> <p>Legislative instrument ID: F2011L00224</p>
	<p>Pools and spas with unsafe design features</p> <p>There is a ban on pools and spas with unsafe 'potty skimmer' style filter systems or outlets with designs that increase the risk of entrapment of hair and other body parts.</p> <p>Ban: Consumer Protection Notice No. 16 of 2011</p> <p>Legislative instrument ID: F2011L00223</p>
	<p>Sky lanterns</p> <p>There is a ban on sky lanterns which are miniature, unmanned hot air balloons that rely on an open flame to heat the air inside the lantern, causing them to lift into the atmosphere.</p> <p>Ban: Consumer Protection Notice No. 17 of 2011</p> <p>Legislative instrument ID: F2011L00227</p>
	<p>Tinted headlight covers</p> <p>There is a ban on tinted headlight covers that restrict more than 15 percent of a headlight's beam. A tinted headlight cover is a coloured panel placed in front of a motor vehicle headlight.</p> <p>Ban: Consumer Protection Notice No. 7 of 2003</p> <p>Legislative instrument ID: F2010L03297</p>
	<p>Tobacco products (smokeless)</p> <p>There is a ban on smokeless tobacco products that are absorbed into the user's system through sucking or chewing rather than burning the tobacco, as with cigarettes or cigars.</p> <p>Ban: Consumer Protection Notice No. 10 of 1991</p> <p>Legislative instrument ID: F2010L03294</p>

	<p>Tongue studs without holes</p> <p>There is a ban on tongue studs without holes which are small beads worn as jewellery on the human tongue, without the need for piercing. They have a small opening on one side only, which acts to create a vacuum when attached to the tongue.</p> <p>Ban: Consumer Protection Notice No. 18 of 2010</p> <p>Legislative instrument ID: F2010L03300</p>
	<p>Toothpaste containing Diethylene glycol (DEG)</p> <p>There is a ban on toothpaste containing more than 0.25% by weight of DEG. DEG is a toxic substance used by some overseas manufacturers as a replacement for glycerine in toothpaste.</p> <p>Ban: Consumer Protection Notice No. 4 of 2009</p> <p>Legislative instrument ID: F2010L03279</p>
	<p>Toys containing beads (inflatable, novelty & furniture)</p> <p>There is a ban on inflatable toys, novelties and furniture containing beads such as loose pellets or small particles, generally made from polystyrene or a similar synthetic material.</p> <p>Ban: Consumer Protection Notice No. 13 of 2011</p> <p>Legislative instrument ID: F2011L00222</p>
	<p>Yo-Yo water balls</p> <p>There is a ban on yo-yo water balls which are liquid filled toys or novelties that have a soft and spongy texture, centre filled with a hydrocarbon based liquid such as toluene (product of petroleum), a thermal plastic rubber outer casing, and an elasticised cord capable of extending at least 500 mm in length.</p> <p>Ban: Consumer Protection Notice No. 20 of 2011</p> <p>Legislative instrument ID: F2011L00230</p>

Interim bans

Interim bans may be made by a state or territory Minister or the Commonwealth Minister. Their duration may be 60–120 days. Check the Product Safety Australia website (www.productsafety.gov.au) for details of any interim bans.

Penalties

Supplying products that do not comply with a mandatory standard or ban is an offence under the Australian Consumer Law (ACL).

Fines for non-compliance are:

- up to \$1.1 million for companies
- up to \$220,000 for individuals.
